Specific aspects of the released version

This release implements some improvements to the visual appearance of the Allerte Italia public portal in compliance with AGID guidelines.

Introduced improvement of API Services with introduction of OAuth2 authentication, completion of services and functionalities offered. Customers are informed to undertake the activities of upgrading their API authentication processes to the new protocol as the one currently adopted will soon be discontinued.

Introduction of a visual indication of 'ready to send' alert templates in order to identify those that are not complete with all the required information and therefore cannot be used for sending.
